Tuition: Parent understands that a place is being reserved for the entire program duration for the skier and that the parent will be responsible for the full tuition of the program unless TAS is notified in writing to withdraw, prior to December 31, 2010. Parent agrees that the obligation for the full tuition will not be reduced by the withdrawal, dismissal, or absence, except for serious illness or injury or moving from the region. Refund requests for serious illness or injury must be made in writing to the TAS Program Director and accompanied by a doctor's statement. An administrative fee of up to 10% of enrollment and transportation may be charged. Such withdrawal, dismissal, or absence would not materially reduce TAS' cost or permit TAS to recoup lost income.
